# AMENDMENT TO CONSENT DECREE AND ORDER

Now comes the West Virginia Board of Dentistry (hereinafter referred to as "the Board") and Jack R. Chambers II, DDS (hereinafter referred to as "the Respondent"), *pro se*, for the purpose of agreeing to an amendment to the Consent Decree and Order entered November 2, 2018, regarding the one hour continuing education requirement related to the West Virginia Board of Pharmacy Controlled Substance Monitoring Program (hereinafter "the CSMP").

The Consent Decree and Order entered November 2, 2018, provides on page 6 that the Respondent shall complete at least one hour of professional education related to the purpose and appropriate use of the WVBOP Controlled Substance Monitoring Program and the Respondent's profile information.

For reasons known to the parties, the Board and the Respondent hereby agree that, in lieu of the Respondent taking a one-hour course on the CSMP, the Respondent may read the entirety of the West Virginia Controlled Substances Monitoring Act and the Board of Pharmacy's legislative rules relating thereto and certify to this Board his completion and understanding of the same, within the time frame provided in the Consent Order, and the Board will accept the same as satisfaction of the professional education requirement under the Consent Order.

#### **ORDER**

Based on the foregoing, the Board hereby ORDERS as follows:

- 1. The Consent Decree and Order is hereby AMENDED to provide for the following method of satisfying the CSMP professional education requirement, in lieu of taking or attempting to take a class on the subject:
- (a) The Respondent shall read the full text of the West Virginia Controlled Substances Monitoring Act, W. Va. Code §§ 60A-9-1 through 60A-9-9;
- (b) The Respondent shall read the full text of the Board of Pharmacy's Legislative Rules, Series 8, governing the Controlled Substances Monitoring Program, W. Va. Code R. §§ 15-8-1 through 15-8-8 (effective April 2, 2018);
- (c) To the extent the Respondent does not understand any of the provisions of the statutes or rules referenced in paragraphs 2(a) and (b), he shall seek clarification of the same from this Board or from the Board of Pharmacy's CSMP office. Otherwise, upon his completion of reading the statutes and rules referenced in paragraphs 2(a) and (b), the Respondent shall execute a certification to this Board that he has read all provisions, understands his duties and responsibilities under those provisions, agrees to abide by them and will ensure that any of his staff are aware of and abide by the provisions of the CSMP; and
- (d) The Respondent shall complete all steps described in paragraphs 2(a), (b) and (c) above no later than May 2, 2019.
- 2. As stated in the Consent Decree and Order, completion of this professional education shall be in addition to the Board's biennial continuing education requirements for licensed dentists as set forth in W. Va. Code R. § 5-11-3.

3. All other terms of the Consent Decree and Order entered November 2, 2018, shall remain the same and shall remain in effect until completed.
