

SUSPENSION OF CE RULES/GUIDANCE DURING STATE OF EMERGENCY

The following rules were suspended pursuant to the Governor's Proclamation of a State of Emergency due to the COVID-19 pandemic:

W. Va. Code R. §§ 5-11-3.6(b), 5-11-3.6(c) and 5-11-3.7(b)

Licensees may complete the required basic life support course via the internet or other electronic means and may complete all required continuing education hours via supervised self-instruction.

Licensees required to have advanced cardiac life support, pediatric life support, or advanced trauma life support may complete them online for re-certifications only. Qualified Monitors qualified by ACLS or PALS may complete re-certifications online as well.

The remaining provision of W. Va. Code R. § 5-11-1 et seq. are unaffected and still apply. The Board will issue any further guidance or instructions deemed necessary.

Any further suspension of rules will be posted to the Board's website.
