I also serve as an examiner for two licensure testing agencies - the Commission on Dental Competency Assessments and the Southern Regional Testing Agency. I will become an examiner for a third agency in the near future. I convey this information to you, not only to familiarize myself to you, but to try to convey my sense of strong commitment of service to the profession of dentistry! And I challenge those of you that see the need to improve the current state of our profession to serve.

The West Virginia Legislature continues to look at ways to ensure West Virginia professional licensing boards comply with the Supreme Court ruling in the case of the North Carolina State Board of Dental Examiners v. The Federal Trade Commission. During the 2016 Legislative Session, representatives of House Government Organization requested a meeting with members of the Board to discuss the Board's membership makeup in an attempt to replace current members with non-market participants, or individuals not licensed by the Board. The removal of knowledgeable and functional members of our profession from its governance would have dire consequences as dentistry is a fast-evolving profession. Also, one of the very important duties of a Board member is to participate in clinical board examinations of prospective licensees, which requires the Board member to be licensed. Therefore, non-market, or unlicensed Board members could not complete this necessary function, which measures minimal competency for licensure. Licensure and regulation is of the utmost importance to ensure the health, safety and welfare of the citizens of this great state. The West Virginia Association of Licensing Boards, as well as Board staff, will continue to monitor legislative activities affecting licensing Boards.

As you may be aware, state law requires review and re-approval of our rules at specific times per each rule's adoption. Mrs. Combs has accomplished this review for the past legislative session, and we have had those rules that needed review accepted by the legislature and executive branch.

We continue to support the efforts of the state Attorney General in his initiative to deal with the opioid abuse problem in our state. Our stance now, as in the past, supports the ADA guidelines for proper prescribing of opioids. I would encourage members of our profession to be ever mindful of our responsibility to the public in the use of pain relieving medication. I can promise that the entire Board takes infractions in this area of practice very seriously.

We continue our efforts to update the Board's website in an effort to streamline license renewal and access to the Board. This has been a challenging task. While there have been difficulties working with our computer programming representatives, I feel we have turned the corner and are seeing light at the end of that tunnel. Evan Dewey has spent a great deal of effort in reigning in this project. Hopefully we will be able to bring it to conclusion shortly.

These are an overview of some of the issues with which the West Virginia Board of Dentistry concerns itself. I want to re-emphasis that our chief mandate is to protect the public. While our members are involved with the practice of dentistry and we understand the challenges that the profession faces, we represent the citizens of West Virginia. Therefore, in closing, I wish to challenge each member of our profession to aspire to the principals we learned in our dental and dental hygiene training - to treat every patient with dignity and respect and provide the type of dentistry to them as we would like to have provided to ourselves and those close to us.

Public Notification of Expenses

The West Virginia Board of Dentistry remains committed to keeping expenses low and continues to find ways to be more efficient within and outside the office. Recently the Board decided to shorten certain meetings in order to save on travel and conference room expenses. We have also been working diligently to process and complete unresolved complaints, and steps are being taken to administer database maintenance and support in-house, which has the potential to save the Board over \$30,000 annually. As always, the Board utilized a detailed budget during Fiscal Year 2016 and was cautious about every dollar spent. This resulted in significantly lower expenses which are reflected in the report below.

We would also like to take this opportunity to make it clear that all fines collected by the Board are transferred directly to the State's General Revenue Fund. When a fine is paid to this Board, we immediately transfer that amount to an account held within the State Treasurer's Office. We do not benefit in any way from money collected from fines, and have no incentive to issue monetary discipline other than means of resolution.

The West Virginia Board of Dentistry will continue efforts to ensure transparency and maximize efficiency throughout the next Fiscal Year. We look forward to providing more outstanding service to West Virginia citizens and the dental community. Thank you.

Continuing Education & Legislative Changes

CONTINUING EDUCATION CHANGES EFFECTIVE SEPTEMBER 1, 2016

Changes to Drug Diversion Training & Best Practices of Controlled Substances - This requirement now includes training on prescribing and administration of an opioid antagonist. This is a legislative mandate from passage of Senate Bill 335 during the 2015 legislative session. Credit for this additional training is required with the CE reporting due on or before February 1, 2018.

Also, the mandate for West Virginia statistics has changed for those licensees practicing outside the State of West Virginia. Dentists practicing in other states may take a course that includes statistical information relative to the state they are practicing in.

Self-Supervised instruction increased from 50% to 80%.

Credit for indigent care increased from 5 to 8 hours for dentists and 3 to 5 hours for hygienists.

EXPANDED DUTIES CHANGES EFFECTIVE SEPTEMBER 1, 2016

The Board sought a change in these rules by removing the word "examining" and words "clinical examinations" from sections concerning dental hygiene expanded duties. Clinical examinations was replaced with "screenings" and screenings was defined. This change clarifies the Board's opinion that an examination can only be billed if a dentist has examined the patient and made a diagnosis.

BACKGROUND CHECK REQUIREMENTS

HB4340, also known as Lynette's Law, requires information regarding completed disciplinary actions in which discipline was ordered, to be posted on a website with public access. Requires boards of regulating professions to require a national criminal background check on applicants being licensed for the first time in West Virginia. The Board has proposed rules, which are going through the rule making process, to implement this law by July 1, 2017.

WV Dental Recovery Network (WVDRN)

A little over two years ago the Board obtained authorization to establish standards and requirements to form professional recovery networks and establish an alcohol and chemical dependency treatment program. The Board has been contracting with the WV Pharmacists Recovery Network (WVPRN) to provide evaluation and monitoring services for the WVDRN.

To date the program has been a success. Two dental representatives sit on the WVPRN Board that are involved in the management of WVDRN cases. The WVDRN reports a plan to implement educational programs involving the dental and hygiene programs in the state to increase awareness of the WVDRN program and give information on steps to take if you suspect a colleague is impaired, as well as provide some general information about the disease of addiction. Education at an early stage of an individual's career is important, because this is primarily the time where these issues begin in many cases.

Renewal Information, Renewal Fees & General Reminders

COMPLETING YOUR FORM

Each year there is a section on your annual Dentists - \$185.00 renewal form where you are requested to list your current employer and related business information. THIS REQUEST APPLIES TO Dental Hygienist - \$75.00 OUT-OF-STATE LICENSEES AS WELL AS IN-STATE LICENSEES. If you are unemployed or retired, please make a notation indicating your current status. It is important that the Board have complete, accurate, and up-todate information on each licensee.

Address changes and change of employers are information that need to be sent to the Board whenever they occur. These changes should be faxed, emailed, or mailed no later than 30 days after the change. Your cooperation with these requirements will be greatly appreciated by the Board staff.

The 2017 Dental renewal requires affirmation of access to the Controlled Substance Monitoring Program for those licensees dispensing, administering or prescribing controlled substances in the State of West Virginia.

Please complete the retirement, administrative and dental services data. We are required by legislative mandate to request and report these numbers. Thank you!!!

The current Continuing Education period started February 1, 2016 and ends January 31, 2018. CE credits are to be reported by February 1, 2018.

Infection Control Information

It is rare for the Board to receive complaints concerning the cleanliness of an office or infection control issues, but these types of complaints are received from time to time. The Board has inspected a number of offices over the last several years to ensure infection control procedures are in place and the guidelines of the Centers for Disease Control and Prevention (CDC) are followed.

<u>All</u> licensees are responsible to ensure infection control procedures are held to the prevailing standards of the CDC guidelines.

The CDC has recently released materials to aid oral health professionals in the prevention of infections in dental settings. These new resources include a summary of basic infection prevention principles and recommendations for dental settings, a checklist to evaluate staff compliance with infection prevention practices, and key references and resources for each area of focus including sterilization, respiratory hygiene, sharps safety, safe injection practices, cleaning and disinfecting environmental surfaces and hand hygiene in dental settings. 


